INVITATION TO COMPETE

ANZAC DAY AIR RIFLE MATCH OFF HAND AND SUPPORTED

Dates: 25th April thru to 18 May 2025

Where: 60 shots on your home range as a postal competition

Cost: \$5 (Aus or NZ dollars) donations to the Anzac Appeal

Disciplines: 10m Air Rifle, 20/25yd/m Prone Rifle, 50m Prone Rifle

HOW DOES IT WORK?

- Assign a club co-ordinator and have them email [QTS](#) to get the spreadsheet.
- Attend your home range/club and shoot a 60-shoot match either 'off-hand' or 'supported' – 15 mins Sighters 75 mins Match time (non-ISSF match)
- Pay your usual range fees plus make a \$5 entry fee / donation to the Anzac Appeal. (inc Re-shoots)
- Your club co-ordinator will collect your scores and add them to a Google spread sheet that will accumulate a country total.
- Enter via emailing gradings@targetsports.org.au to advise you wish to participate.

OBJECTIVE

- To raise funds for the ANZAC Appeal in NZ and AUS.
- To promote participation and increased skill in competitive rifle shooting at grassroots level in an international match in the Spirit of ANZAC Mateship.

WINNER

To follow in the tradition of ANZAC the focus of this match is a team's event. The winning team will be determined by the addition of the highest descending scores of the equal number of competitors for each team. Scores of all participants will be published via email to all competitors.

*Clubs can collect cash and make one direct debit payment to TSNZ/QTS or have members transfer directly to the TSNZ/QTS.

Rules

1. The matches for the Anzac Appeal competition must be shot in the specified date window.
2. Matches can be shot on any appropriate shooting range subject to your range orders.
3. Matches must be supervised/witnessed by an appropriate qualified person.
4. **The co-ordinator must enter scores into the Google document via the link.**
5. Matches can be shot using either electronic or paper targets.
6. Paper proof of scores must be kept and witnessed by signature/name/date of supervisor.
7. All matches shot will be scored electronically use decimal scoring.
8. Air Rifle 10m paper targets scored with electronic scoring machine (Disag or Rika) will be accepted as an electronic score.
9. **.22 Rifle Matches will be counted/converted back to non-decimal scores (ie paper scores/whole numbers) to allow participation of country clubs without electronics.**
10. Officials can also take part in the competition. However, they will require someone else to officiate and enter scores for them.
11. Scores from other competitions that fall within the match windows can be used for this competition.
12. Re-do shoots are allowed if you want to try for a higher score, but only one score for each discipline counts.
13. Matches can be shot in the Supported Position if you can't shoot Unsupported. (ie "Prone" can be shot seated at a bench with jacket and sling and both elbows on bench similar to WSPS position, no medical certificate required for this – purely up to shooters good judgement.
